# Group 10-Year Level Term Life Insurance **Plan Summary**

You certainly understand the importance of having sufficient life insurance. Now you have an opportunity to make sure that you have the amount of coverage needed. Your loved ones will appreciate the peace of mind this Plan provides, with benefits up to \$1,000,000 that will let them go on with their lives with fewer financial concerns.

# **About This Plan**

You may apply for \$50,000 to \$1,000,000 in 10-Year Level Term Life insurance coverage (in \$5,000 increments). Coverage continues as long as you pay your premium when due and the Group Policy remains in force. Your amount of insurance will not decrease due to age during a level term rate period.

# Eligibility

All IMA members under age 70 may apply for coverage for themselves, their spouse age 70 or under and all unmarried dependent children ages 15 days to under age 26. Member must be actively at work (at least 20 hours per week) and dependents must be able to carry on all the normal and customary activities of a person of like age and sex at the time of enrollment.

A dependent who is also a member may apply for either member or dependent coverage, but not both. If both member and spouse are covered as members, neither may insure the other as spouse and only one may insure any eligible children.

## Maximum benefit amounts

IMA members and their Spouses can apply for amounts up to \$1,000,000 in increments of \$5,000. While this process requires full medical underwriting, it may give you access to higher benefit maximums and to the most competitive rates.

## Eligibility Amounts at time of application:

- Under age 55 up to \$1,000,000
- 55 through 59 up to \$250,000
- 60 through 64 up to 150,000
- 65 through 69 up to \$75,000

Option 1:\$5,000 of coverage is available at \$0.95 semi-annually **Dependent Children:** Option 2:\$10,000 of coverage is available at \$1.90 semi-annually

## Accelerated Life Benefit<sup>1</sup>

The Accelerated Life Benefit option is available to help terminally ill insureds during a difficult, and often financially challenging, time. Under this provision, you may request one advance payment equal to 80% of your in force life insurance up to \$500,000 to be paid while the terminally ill person is still alive. The amount of insurance payable after death will be reduced by this payment.

## Accidental Death and Dismemberment coverage<sup>2</sup>

The Member and Spouse can elect the same level of Accidental Death & Dismemberment (AD&D) coverage as for Life Insurance coverage. In addition, if you are seriously injured in a covered accident and sustain loss of limb, eyesight or other injuries, a partial benefit may be payable. AD&D semi-annual costs are \$0.60/\$5,000 if under age 65 and \$0.90/\$5,000 age 65 through 80.

## Waiver of Life Insurance Premium Disability Benefit

The Member pays no premiums if he/she becomes totally disabled, as defined in the certificate. Your life insurance coverage will continue at no cost to you if you become continuously totally disabled for at least 6 months and if your disability occurs before age 60.

#### Is a medical exam required?

You must complete a standard application. When you apply, simply answer the health questions. Even if you have a health condition, you may still qualify. Depending on the amount applied for, a paramedical exam and blood test may be required, which will be scheduled at your convenience and at no cost to you.

#### Will this level term plan pay in addition to other coverage?

Yes. The level term plan pays in addition to any other insurance coverage you have. The plan also stays with you until your coverage ends — even if you change jobs. If also electing coverage under the level term life insurance plans, a combined maximum benefit amount of \$1,000,000 between the level term life insurance plans and the annual renewable term life insurance will apply.

#### What are my options when my 10-year term comes to an end?

Depending on your age and health, you may qualify to apply for another 10-year level term plan at the current rate for your age at the time of enrollment. If not, you will be automatically enrolled in the Ultimate Plan group policy and will be charged Ultimate Rates subject to the provisions and premiums of the plan. Coverage terminates at age 80. At age 70, coverage will be reduced to 80% of the original benefit amount and at age 75, coverage will be reduced to 55% of the original benefit amount. The Amount of the Insurance will not decrease due to age during the Level Term Life Period.

#### How long can my coverage continue?

Your coverage can continue as long as you have not reached the end of a 10-year period, you pay your premium when due, have not reached age 80, remain in an eligible class, the insurance continues for your class, and the group policy for the IMA remains in force. ### Would I have the ability to continue coverage, should my plan end?

Yes, in many instances. If your insurance ends for a reason other than non-payment of your premiums, you may be able to convert your coverage into an individual life insurance policy from Metropolitan Life Insurance Company or an affiliate without providing evidence of insurability. We know that you buy our products and services because you trust us. This notice explains how we protect your privacy and treat your personal information. It applies to current and former customers. "Personal information" as used here means anything we know about you personally.

#### **SECTION 1: Plan Sponsors and Group Insurance Contract Holders**

This privacy notice is for individuals who apply for or obtain our products and services under an employee benefit plan, group insurance or annuity contract, as an executive benefit, or as otherwise made available at your work or through an association to which you belong. In this notice, "you" refers to these individuals.

#### **SECTION 2: Protecting Your Information**

We take important steps to protect your personal information. We treat it as confidential. We tell our employees to take care in handling it. We limit access to those who need it to perform their jobs. Our outside service providers must also protect it, and use it only to meet our business needs. We also take steps to protect our systems from unauthorized access. We comply with all laws that apply to us.

#### **SECTION 3: Collecting Your Information**
